

Disqualifiers to Employment



Read the following list of disqualifiers and **initial next to each disqualifier** indicating you have read the disqualifier, you understand it, and you are not disqualified from applying for a Police Officer position.

FEDERAL LAW

- _____ Applicant has been convicted in any court of a crime punishable by imprisonment for a term exceeding one year. *(18USC922(g)(1))*
- _____ Applicant is a fugitive from justice. *(18USC922(g)(2))*
- _____ Applicant is an unlawful user of, or addicted to any controlled substance. *(18USC922(g)(3))*
- _____ Applicant has been adjudicated as a mental defective or who has been committed to a mental institution. *(18USC922(g)(4))*
- _____ Applicant, being an alien, is illegally or unlawfully in the United States; or has been admitted to the United States under a nonimmigrant visa. *(18USC922(g)(5))*
- _____ Applicant has been discharged from the Armed Forces under dishonorable conditions. *(18USC922(g)(6))*
- _____ Applicant, having once been a citizen of the United States, has renounced his or her citizenship. *(18USC922(g)(7))*
- _____ Applicant is subject to a court order that restrains the applicant from harassing, stalking, or threatening an intimate partner or child of an intimate partner. *(18USC922(g)(8))*
- _____ Applicant has been convicted in any court of a misdemeanor crime of domestic violence. *(18USC922(g)(9))*

STATE LAW

- _____ Applicant has a FBI or OSBI record of a conviction of a felony, a crime of moral turpitude, or domestic violence. *(700S3311(D)(1),(D)(2)(a),(J)(1)(a-b),(E)aru1(J)(S))*
- _____ Applicant has received a verdict of guilt or entered a plea of nolo contendere, or is participating in a deferred sentence, for a felony, a crime involving moral turpitude or a domestic violence offense. *(700S3311 (D)(1),(D)(2)(d),(J)(1)(c),and(J)(6))*
- _____ Applicant is subject to an order of the Council (CLEET) revoking, suspending, or accepting a voluntary surrender of their peace officer certification. *(700S3311(D)(J),and(E))*
- _____ Applicant has voluntarily surrendered and relinquished their peace officer certification to CLEET within five (5) years of the date of this application. *(700S3311(J)(9)(a))*
- _____ Applicant has had their police or peace officer certification from another state-revoked or voluntarily surrendered within five (5) years of the date of this application. *(700S3311(J)(1)(e),aru1((J)(9)(b))*
- _____ A psychologist licensed by the State of Oklahoma within one (1) year of application has found applicant unsuitable for employment or certification. *(700S3311(D)(2)(b))*
- _____ Applicant does not possess a high school diploma or a GED equivalency certificate. *(700S3311 (D)(1),(D)(2)(c))*
- _____ Applicant is under 21, or more than 45 years of age prior to certification as an officer. *(700S3311(D)(2)(e))*
- _____ Applicant cannot provide proof of United States citizenship or resident alien status. *(700S3311(D)(2)(j))*
- _____ Applicant has willfully misrepresented information in an employment application, application to the Council (CLEET), records of evidence, or in testimony under oath. *(700S3311(J)(1)(d))*
- _____ Applicant is currently undergoing treatment, and has been committed to a mental institution or mental health facility, for a mental illness, condition, or disorder. *(700S3311(D)(1),(J)(1)(j),and(J)(7))*
- _____ Applicant has an interest, financial or otherwise, in a wrecker or towing service, or with a person or in a business that derives business or income from a wrecker or towing service. *(47 O.S. § 956)*

UNDER CHIEF'S DIRECTIVE

- _____ Applicant is under indictment, has charges pending in any court, or is currently under investigation by any law enforcement agency for an offense that would disqualify the applicant from consideration for the position of police officer.
- _____ Applicant is on probation, parole, or deferred sentence, until such parole is completed, unless the conviction is for a crime which otherwise would disqualify the applicant.
- _____ Applicant has ever distributed or manufactured illegal drugs, solicited for sale, with or without profit, or participating profit, or participated in any way in the above sales. (this includes marijuana)
- _____ Applicant has used, within the past 5 years, any hulloecogenic drugs, which include, but not limited to, lysergic acid diethylamide (LSD), phencyclidine (PCP), MDMA (ecstasy), mescaline, Peyote, Ketamine or psilocybin.
- _____ Applicant has used, within the past 5 years, any substances, including those listed in the Oklahoma Controlled substances act, which include, but not limited to: Amphetamines, Methamphetamines, Steroids, Cocaine, Opium, Barbiturates, Heroin, Morphine and Ecstasy.
- _____ Possession of a medical marijuana card after employment.
- _____ Applicant has used or possessed marijuana in the past 18 months with or without a physician prescriptions (Marijuana, whether it is used medically or recreationally, remains a violation of the Federal Controlled Substances Act 21 U.S.C §801)
- _____ Applicant has been convicted of two or more DUIs, DWIs, or DUID at any time, or has been charged with a DUI, DWI, or DUID within the past three (3) years.
- _____ Applicant has had a conviction for reckless driving, attempting to elude, racing, or leaving the scene of an accident within in three (3) years.
- _____ Applicant completed the State basic police certification course while employed with another law enforcement agency in this state and is within one (1) year of that certification.
- _____ Applicant has received any discharge, as stipulated on their DD214, less than honorable.
- _____ Applicant does not have the ability to obtain an Oklahoma driver license.
- _____ Termination from other Law Enforcement Agency, or resignation while under investigation.
- _____ Applicant has Tattoos that are visible while wearing any Department issued uniform. (send photo(s) on how it would be covered (i.e., make-up, band-aid, sleeve), reviewed on a case by case basis)
