## City Millage Rate at 14.5 for 2024 Tax Year

This year's tax statement from the Cleveland County treasurer shows the City of Moore's millage rate at 14.5. This remains below the 16.5 ceiling, as promised by Moore's City Council over 6 years ago.

We value a fiscally responsible approach to managing the City's resources—one that balances the needs of today with the opportunities of tomorrow. A key aspect of this strategy is maintaining a stable millage rate and issuing bonds only when necessary. Below are the City's millage rates for the past 5 years:

While stability is key, it's equally important to recognize when to invest in critical projects that cannot be funded solely through sales tax revenues. Bonds provide us with a stable funding source to finance large-scale infrastructure improvements, such as engineering, design, and road reconstruction, or building new public facilities. These investments are essential for maintaining the high quality of life we all enjoy.

Issuing bonds only as needed ensures we aren't overburdening our future budgets with unnecessary debt. Each bond issuance is carefully evaluated based on its potential benefits to the community. By issuing bonds strategically, we can make meaningful investments that enhance our city while maintaining our strong financial standing. With responsible leadership and continued support, we can continue to build a city that thrives today and for generations to come.
