The following questions have arisen and we are sharing that information with all prospective bidders.

1. Question: Section 5 of the RFP states, “Clearly list the pricing for any optional features.” What is meant by optional features?

Answer: Some of the provided wear trial self-contained breathing apparatus (SCBA) were base units and lacked optional features. So, yes, items such as buddy breathers, telemetry, etc., are examples of other optional features.

2. Question: Section 4.6 of the RFP states, “If rechargeable, provide pricing for charging station and spare battery pack.” What further information can you provide for this?

Answer: Different variations exist from disposable to rechargeable batteries. For the given SCBA, delineate the type of battery, if the battery is included, if not, what is the price for the battery, what is the price of a spare battery, what is the price of charging stations/connections, etc.

3. Question: Section 5 of the RFP states, “Manufacturer and model numbers.” What further information can you provide for this?

Answer: Please list applicable information for the purpose of potential future purchases and the ability to match initial purchases.

4. Question: Section 5 of the RFP states, “Clearly state the warranty details, terms, duration, and associated cost for each component?” What further information can you provide regarding associated cost for each component?

Answer: Please clearly state warranty schedule/information of SCBA, Facepiece, and Cylinders. That is necessary throughout the service life of the items. Furthermore, if there is any special maintenance schedule necessary to fulfill requirements of the warranty.

5. Question: Section 5 of the RFP states, “ Cost of SCBA tech class per person.” What is the rough number of how many need to be SCBA tech trained, and would virtual satisfy?

Answer: Virtual training could be sufficient if it is comparable to onsite training. Membership interest and cost will likely dictate how many we train. Please provide pricing per individual and/or group pricing (no more than 6) for both delivery options.

6. Question: Section 4.5 of the RFP states, “Bluetooth or radio interface pairing capability,” and Section 5, “equipment for paring radio to SCBA.” What is the number of radios planned for pairing?

Answer: At least 65.

7. Question: Section 3 of the RFP states, “4500 PSI Cylinders.” Which 4500 PSI cylinder is this? The 30-minute or 45-minute?

Answer: 30-minute.
